


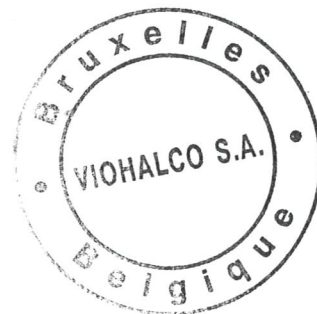
**10. Additional Information<sup>xix</sup>:**
